This research is purposed to study about state and problems in organizing sports and recreation activities of government authority and to compare state and problems in organizing sports and recreation activities. Five groups of government authorities are the group of industry, the group of commerce and service, the group of communications, the group of agriculture, and the group of energy. The third purpose of making this thesis was to compare state and problems in organizing sports and recreation activities between the administrators and the officers who attended sports and recreation activities. Fifty-three pre-test questionnaires were distributed to the officers who responded in sports and recreation activities in each government authorities and 53 pre-test questionnaires which accounted for 100 percent were completed and returned. Five hundred and fifty questionnaires were distributed to 150 administrators and 400 officers. Four hundred and fifty-six questionnaires which accounted for 82.91 percent were completed and returned. The obtained data were then analysed in terms of percentage, mean and standard deviation. The differences and the relationships among groups were determined by F-test, Scheffe's, and t-test.

The findings were as follows:

1. Forty-eight out of 53 government authorities were organized sports and recreation activities and 5 government authorities were not. Most of government authorities had less skilled officers in physical education responded in sports and recreation activities which accounted for 66.04 percent. The money is received from the head government authorities. Among the sport courts of government authorities, petanque ground had the greatest number. The government authority had its owned department of sport and recreation activities which was organized in the form of the committees.

2. According to the comparison between state and problems in organizing sports and recreation activities of government authority, the findings were as follows:

2.1 The state in organizing of government authorities were found to be differences perceived at .05 significant level, which the group of communications had more state in organizing than the group of agriculture and the group of commerce and service.

2.2 There were no differences in problems in organizing on man, money, materials, and management among the government authorities at the .05 significant level.

3. According to the comparison between state and problems in organizing sports and recreation activities between the administrators and the officers who attended sports and recreation activities, the finding was that there were no differences in state and problems in the group of industry, the group of communication, and the group of agriculture at the .05 significant level. The state and problems in organizing on man and management in the group of commerce and service were found to be differences perceived at .05 significant level. The state and problems in organizing on man, money, materials, and management in the group of energy were found to be differences perceived at .05 significant level.
