The objective of the study on The Legislative Control over The Bureaucratic Administration: A Case Study of Thai Legislative Process are to study on step, mean, an essence of bureaucratic administration control by motion technique. An important motion which be effective to government stability and security are also emphasized in order to seek for proposal which will encourage process of passing a vote of noconfidence be more effective. The result of the study are found that a political impact are:

1. An executive resignation. A resignation of General Pahon Phonphayuhasena government cause from general debate on Royal property motion (July 27, 1937). A resignation of Major Admiral Tawan Thamrongnawasawaddi government cause from general debate on vote of no-confidence in cabinet (May 19 - 26, 1947). A resignation of General Kriengsakdi Chamanun cause from general debate on vote of no-confidence

in Prime Minister (March 3, 1980). Realisation on an occurred defect are the reason for resignation in each government.

- 2. House of Representatives. Generally, dissolution cause from submitted motion on general debate, for example, general debate for the purpose of passing a vote of no-confidence in cabinet (May 17 18, 1995), Sor Por Kor 4-01 title document issue in Phuket Province while Mr. Chuan Leekpai is a Prime Minister. Separation among affiliated government political party while general debate for passing vote of no-confidence in Mr. Banham Silapa-archa took place (September 18 21, 1996).
- 3. Separation among affiliated government political party. A consequence of general debate are seperation among affiliated government political party which lead to some Minister resignation and Member of Parliament separation in General Por Piboonsongkram government (August 29 30, 1957). Vote abstention of confidence for Palangtham political party from general debate for passing vote of no-confidence in individual Minister (case of Mr. Suchart Tonchareon), (May 8 10, 1996). Condition proposal on vote for support Mr. Banharn Silapa-archa in general debate for the purpose of passing a vote of no-confidence in Prime Minister (September 18 21, 1996). Such a political activities are the separation among affiliated government political party which be cause from a general debate.

The proposal are that more effective debate depends on quality of motion submitted by opposition party. Non-transparent administration issue which be effect to nation or public interest should be submitted more than personal interest issue. Finally, debate should be emphasized on essence not be non sense, and also the M.P. should act as a good pattern who give people a good quality of life.
