according to the organic law on counter corruption ACT, B.E. 2542 (1999),

Constitution of the Kingdom of Thailand has been stated that the Organic Law on Counter Corruption shall at least contain the prohibitions of the commission of an act representing a conflict between personal (private) interests and public interests for which holders of political or other state officials must be accountable both during the currency of office and after the vacation of office. Thus, The Organic Law on Counter Corruption Act, B.E. ๒๕๔๒ (1999) has contained the provision of the prohibition of the commission of an act representing a conflict between personal interests and public interests and also has the provision of criminal offence for those who commit to break the rules

Since the enactment of the Organic Law on Counter Corruption Act, B.E. ๒๕๔๒ (1999) , The National Counter Corruption Commission has enacted the order to have the political position holder only the position of Prime Minister Ministers Local Administrator and Deputy Local Administrator as the position of the prohibition of engagement of the business as provided under the section ๑๐๐ of this Organic Law on Counter Corruption. Therefore it still yet consider to provide other political positions for having such prohibitions.
