

## ABSTRACT

The study of the Performance Appraisal on the Training of Juvenile Delinquency was conducted in the Ban Pranee Training School for Girls, the Central Observation and Protection of Juvenile Center. The investigation covered the supervisors of the training center and its staff totally 43 in numbers and 136 juvenile delinquency imposed by courts to be admitted into the Ban Pranee Training School for girls. The objectives of the study were as follows

1. To assess the performance of training including the recuperation of the female juvenile delinquency and the role of the involved personnel of the training school.
2. To study problems and obstacles in the training in associated with the requirements of female juvenile, who were trained in the Ban Pranee Training School for Girls.
3. To propose approaches to further improve the training and organizing the Ban Pranee Training School for Girls.

Questionnaire was employed for data collection to allow supervisors of the training center, staff and the training female juvenile delinquency to respond and personally collected the returned data.

**The findings were briefly reported as follows :**

1. By following the set objectives of the supervisors and the staff, the training of female juvenile delinquency in the Ban Pranee Training School for Girls of the Central Observation and Protection Center was achieved. The trained female juvenile

delinquency accommodated knowledge and comprehensiveness in the levels of common subjects, ethics, physical exercises and vocational subjects and was able to implement in the rather high level. It was agreed upon the usefulness in the development of the behavior, personal recuperation to become good citizen meeting the requirements of the objectives and goals of the training center.

2. Processes of training were moderately appropriate.

3. Basic factors or input factors were moderately appropriate based on factors in budgeting insufficiency of personnel.

**The following recommendations were made**

1. Curriculum of the training should be improved to standards by adopting new curriculum such as computer in order to be accepted by labor market and duration of its completion to match the terms of court adjudication on training.

2. Concerning ethics teaching, there should be survey on interest and requirements of juveniles and teaching aids such as slides, movies, and wood puppets etc. should be as helps to motivate the interest.

3. Concerning the services of social welfare, by ration, there should be increase in numbers of technique professionals such as social scientists, psychologists to cover the numbers of training juveniles.

4. Consideration on gender should be made in categorizing the training center, however, it should correspond with the typological offense of the juvenfle and the duration of the training.

5. Concerning systems of selection in female juvenile for training, there should be implementation of classification system for the benefits of study and analysis on juvenile problems that the activities organizing would reach the effectiveness of training.

6. There should be promotion for sources and funding to support the training and helping juvenile delinquency such as teaching aids.
