Abstract

This research is survey research. The objectives are to study the awareness of the police on crime prevention and suppression in Eastern Sea Board in general awareness in knowledge, skill, morale, spirit, instrument, finance, family relationship and assignment. The population are 83 provincial police at Lamchabang Police Station Chonburi police station and 52 from Mabtapud Police Station, Rayong. The data were collected by means of questionnaires in March B.E. 2537. Statistical methods used to analyze the data were percentage and Chi-square. The results of the study are :

In general, the police in Eastern Sea Board are aware on crime prevention and suppression.

The police are skillful in crime prevention and suppression, their duties are appropriate for their individual capacity. The duty plans are always reviewed. The police have legal knowledge for their performance. The disciplines are always trained. The police station have long-term and short-term plans for crime prevention and suppression, consulting and brain storming for the important work. The police station are not aware on strike practice, weapon usage and training about new cases of crime.

In general, the police are aware on having morale and spirit for crime prevention and suppression. They are proud of their station, always exercise to get ready to their performance, are familiar with the villagers, are pleased with their work and compromise to the others. The arrangement of duty periods is appropriate. The police can present idea for adjustment of their teamwork. They have chance for promotion. The chiefs are familiar with their fellows and give them the promotion. The moral system is used for promotion. The police can consult their chiefs about their performance. The punishment is reasonable. The police want to continue their work.

In general, the police stations in Eastern Sea Board are not get ready on instrument and finance because they are not sufficient and out of date. The draw of instrument and special allowance are in convenient and waste their time. The special allowance management is not appropriate. Fire extinguishers, police cars, motorcycles, fuel, telephones, guns, hand cuffs, radio communication, tight-reflective gowns, electric torches, color sprayers, facsimiles, photo copy machine, computers are not sufficient but the working rooms are suitable for working condition. The number of good residence is sufficient

The police's families have enough for their living. The family relationship is in good level and they support the police profession but sometime there is some conflict in the police's families.

In general, the police are get ready for their assignments because of good coordination within their stations. The coordination with the other units for criminal cases are in good level. The police station introduce crime prevention to people and make public relation to urge people for crime prevention and suppression. The investigators can follow serious cases, narcotic cases, gambling cases, assault cases effectively. The investigation is fast and to make file of cases is skillful and just. The connected people are given good invitation and appropriate introduction. The prisoner control system is well management and skillful. The police please with their duties but the police boxes inspection spots are not sufficient and finally the police manpower is not sufficient for the performance. Variable relationship show that age, working time, rank educational level, the experience in investigation, financial status are not make different to crime prevention and suppression in Eastern Sea Board. Level of significance is 0.05.
