The sample groups of this research are the police who working in the third provincial police divistion region which had total amount 280 persons and buddhist monk who had position in abbot, vice-abbot, assistant abbot and priest which had total amount 280 priests. The questionaires were used for collecting the information and the result of this research are as the following:

From the study, we can summarize that this research sceepts all hypotheses. Eventhough, we bring many factors of background like age, the amount of rainy season, the public service age, position of priest, position, a religious denomination, the operating work, the highest education, the marital status before to go into priesthood, the marital status, the cause of interesting in Buddhism and the cause of

relationship with Buddhism which including in this research. It is show that there is not different in opinion for the Buddhist monks role anymore. All priests have agreed with the role in sermon, training and instruction to people at present. The role of good precedence to people and development and to give a helping hand to a community is another way to protect the crime.

In the view of Buddhis monks, we found that the buddhist monks who were accepted in the theory of Buddhism, have good knowledge in Buddhism, to perfrom according to doctrine and have good basic knowledge in Buddism before to go into presthood will have better role than the Buddhis monks who lack of these qualification.

In the view of the police, who believe in a law of fate and ever been a boy who serves a prist in a monastery before, has accepted and performed according to doctrine regularly will agree and accept the Buddhist monks role in sermon, training instruction, development and to aid to a community in order to be a good precedence better than the police who didn't believe in Buddhism.

RECONNENDATION

- 3. The government should concern more about Buddhis monks role by supporting the budget, promotion and value to Buddhis monks and people for the crime protection more than the past.
