



Resolving the Causes of Ruin Problems by the 5 Precepts Village Project, Khon Kaen Province

Abstract:- *The objective of this research was to study the Resolving causes of ruin problems by the 5th Precepts Village Project and recommendations in Khok Yai Village, Ban Fang Sub-district, Ban Fang District, Khon Kaen Province. Collecting data by using a questionnaire, collecting data from a sample of 321 people, then analyzed and processed with a ready-made computer program. The statistics used are percentage, mean, standard deviation. The results showed that 1) all 321 respondents were female, 57.01% were female, 42.99% were male, 38.32% were 21-40 years old, 28.662% had primary education. The resolving causes of ruin problems by the precept 5 village project as a whole is at a high level. When considering each aspect, they are in descending order as follows: drunkenness, excursion to play, idle work, moonlighting, gambling, making friends with evil people. Suggestions are as follows: During the Buddhist Lent period, all shop operators should refrain from selling liquor. Need the community leaders to announce that the merit-making event in the village is a merit-free event. Need people in the village to help support activities that are beneficial to the village and temple. Learn about the dangers of nightlife and how dangerous they are. Need the community leaders to announce that the merit-making event in the village is a merit-free event that is free from alcohol and gambling. Need everyone in the village to be more serious in managing the gambling in the village. Parents should admonish their children about companionship. Village leaders should vigorously warn the villagers to stay away from people who break the law. Need to deal with illegal things like drugs, racing. Need the village to generate income for unemployed people to do. Have an OTOP group in the village to give the villagers an opportunity to earn income and gain knowledge from work.*

Introduction

From the situation of the country in the past to the present, Thailand faces many problems, consisting of illegal actions, crime problems, drug addiction and the Causes of ruin. The division of thought, in which these problems are all caused by a lack of consciousness, morality and ethics, will result in social conflict. Causes of ruin is an important problem at the national level which the government has an urgent policy to seriously solve this problem. Causes of ruin problem and drug problem is becoming more and more severe and affecting the development of the country. both in terms of economy, society, politics, security, as well as the moral and ethical values of the people in the country, It was found that the Causes of ruin epidemic and drugs have spread in every area including villages, communities, schools and even within temples, which are places where people are respected and respected, are bad for the Buddhist community. Religion is very likely to cause a great decline in faith (Chuaichu,W.,2020).

Prevention and treatment of drug problems in the community by using a Buddhist ethical approach that is to prevent and solve drug problems in the community through physical and mental therapy. Physically, they will be treated with medical methods from the district public health and by exercise and vocational training. As for the mental aspect, knowledge is given both as secular knowledge, that is, knowledge for an honest career after quitting drugs. At the same time teaching the principles of Buddhist ethics in Buddhism to be aware of the nation, religion, monarch, and gratitude to those who are benevolent to themselves so that those who quit drugs and come back. Returned to taking drugs again. Individuals and youth at risk of drug



addiction have a clear pattern of protection based on Buddhist ethics. It is evident that the causes of drug addiction problems in the community in Khon Kaen are what causes and what Buddhist ethics principles can be applied to solve and prevent drug problems in the community (Palangang, K., 2019). Therefore, the research team is interested in doing research on Resolving causes of ruin problems, in principle, Ban Khok Yai Village 5 Precepts Project that people in the villages participated in solving the problem by applying the 5 Precepts to solve the problems of people in the community and guidelines. Prevent Causes of ruin in the village. The Village Keeping the Five Precepts Project is based on the Sangha's intention to strengthen and reconcile the people in the nation to achieve peace and harmony, in harmony with the intent of creating reconciliation by allowing the Buddhists to lead the principle. The five precepts come and practice in daily life. Venerable Somdej Phra Maha Ratchamangkalajarn who performed the duties of the Patriarch and also promoted education Resolving causes of ruin problems in the future as a guideline for people's participation in the community.

Research Objectives

1. To study the Resolving causes of ruin problems by the 5 Precepts Village Project, Ban Khok Yai, Ban Fang Subdistrict, Ban Fang District, Khon Kaen Province.
2. To study the people's recommendations on Resolving causes of ruin problems by the 5 Precepts Village Project, Ban Khok Yai, Ban Fang Sub-district, Ban Fang District, Khon Kaen Province.

Methodology

The population is 1,627 people living in Khok Yai Village, Ban Fang District, Khon Kaen Province (Department of Administrative Affairs: 2019).

Techniques and methods for selecting samples: The sample size used in this research study The researcher determined the sample size by using the Taro Yamane formula (1967) i.e., 1,627 people living in Khok Yai Village, Ban Fang District, Khon Kaen Province. Therefore, 321 people were enrolled in this study. The researcher conducted random sampling by distributing questionnaires to people found in Khok Yai Village Community Area, Ban Fang Sub-district, Ban Fang District, Khon Kaen Province, until the required amount was reached.

The tool used for data collection in this research was a questionnaire created by the researcher. The questionnaire style was a combination of Checklist and Rating Scale. The toolmaking was applied to the principles and methods of toolmaking of Likert and Tharungsee, K. (2003; Wiengkae, W., et al. 2016).

Data Analysis and Processing: The researcher has analyzed the data by computer program. The sequence of the analysis steps are as follows. (1) Verify the integrity of the data in the recovered tool. (2) The enumeration results and scores were used to find statistical values; general data of the respondents were analyzed for frequency and percentage. Analysis of the Resolving causes of ruin problems by the 5 Precepts Village Project, Ban Khok Yai, Ban Fang Subdistrict, Ban Fang District, Khon Kaen Province, for Mean, and Standard Deviation.

Statistics used in data analysis, the researcher analyzed the data using descriptive statistics such as Percentage, Mean and Standard Deviation.



Results

The results of the research on Resolving causes of ruin problems by the Precept 5 village project found that the opinions on the overall resolving causes of ruin problems behavior were at a high level with a mean of 3.84 and a standard deviation of 0.55. In descending order: drunkenness, excursion to play, idleness at work, moonlighting, gambling, making friends with evil people.

The drunkenness: The overall resolving causes of ruin problems were found to be at a high level with a mean of 3.97 and a standard deviation of 0.62.

The moonlighting: The overall resolving causes of ruin problems were found to be at a high level with a mean of 3.82 and a standard deviation of 0.66.

The excursion to play: The overall resolving causes of ruin problems were found to be at a high level with a mean of 3.84 and a standard deviation of 0.71.

The gambling: Overall Resolving causes of ruin problems was found to be at a very high level with a mean of 3.80 and a standard deviation of 0.74.

The making friends with evil people: The overall Resolving causes of ruin problems was found to be at a high level with a mean of 3.78 and a standard deviation of 0.80.

The idleness at work: The overall resolving causes of ruin problems were found to be very high with a mean of 3.83 and a standard deviation of 0.78.

Other suggestions on Resolving causes of ruin problems by the 5 Precepts Village Project, Ban Khoi Yaa, Ban Fang Sub-district, Ban Fang District, Khond Keen Province. It was found that 11 people who answered this open-ended questionnaire, out of a total of 321 people, had the first recommendation being drunkenness, accounting for 3.42 percent. Place gambling accounted for 3.42 percent. Making friends with evil people, 2.49 percent. Excursion to play accounted for 1.55%. tourism, accounting for 1.24 percent. And idleness at work, accounting for 0.93%.

Discussion

From the research results Resolving causes of ruin problems, the results of the research can be summarized as follows.

1. The overall drunkenness, it was at a high level with an average of 3.97. This may be because the people have campaigned for people in the community to stop drinking alcohol and persuaded them to turn to anti-drug sports instead of strictly observing the five precepts, Surameyamathanaweramani. There is support for the merit-making event in the village as a merit-free event with alcohol and gambling. When friends or acquaintances drink alcohol and



persuade them to steal other people's things or property, they will refuse and notify the village leaders or officials to prosecute them. There is a meditation practice, abstaining from alcohol and refraining from killing animals during the Buddhist Lent period. The findings are consistent with Chuaichu, W.(2020), a research study titled "Guidelines for the Prevention of Causes of ruin in Temples according to the White Temple Project of A Ta Khao District, Trang Province. It was found that: 1) The operating conditions of the Causes of ruin Prevention Guidelines within the temple according to the White Temple Project of A Ta Khao District, Trang Province overall are at a very high level. When considering each aspect, it was found that the smoking prevention guidelines had the highest average followed by gambling prevention guidelines, alcohol drinking prevention guidelines, and drug prevention guidelines having the lowest mean.

2. The overall moonlighting is very high with an average of 3.82. This may be because the people saw that during the night at festivals, they would stop drinking alcohol. Because if drinking alcohol will cause a lack of consciousness, causing quarrels. It should be avoided and avoided nightlife that will cause unnecessarily waste of money. When a persuaded acquaintance or friend cannot refuse an invitation for a night out from a senior relative, the supervisor will travel in moderation, and do not break the precepts. When a friend or acquaintance goes out for a night, they often warn them because nightlife is dangerous to life and property. There are ways to avoid a night out with friends by giving more direct reasons than lying.

3. The overall excursion to play is at a high level with an average of 3.84. This may be because the people do not promote ceremonies or activities that include spirits, feasts and slaughter of animals for feasts. Support activities that educate about propagation and living in awareness of the causes of ruin. Excursion to creative play is a play that promotes distance from addiction and Causes of ruin. Refrain from going to play and drinking that affect one's career and property. If it is necessary to go out and see the play for fun from time to time, avoid flirting with people who are not their lover.

4. The overall gambling is at a very high level with an average of 3.84. This may be because the people helped to clear the gambling in the village. Do other activities in your spare time instead of gambling. Refrain from gambling during Lent. Encourage government officials to educate them about the dangers of gambling. The findings, in line with Chuaichu, W. (2020), conducted a research study titled "Guidelines for Prevention of Causes of ruin found that: The overall operating conditions for preventing Causes of ruin were at a high level. When considered on a case-by-case basis, it was found that the guidelines for prevention of smoking had the highest average, prevention of gambling, prevention of alcohol consumption and drug prevention, respectively

5. making friends with evil people Overall, it was at a high level with an average of 3.78. This may be because people support activities to cultivate good people, refrain from gambling and intoxicants organized by the temple community, educate youth, Avoid and refuse to associate with people who encourage you to drink and gamble on a daily basis. Refrain from dealing with people who are harmful to society such as drug addicts, gambling addiction which will endanger life and property, not associating with verbal persons will cause instigation of friends, relatives, and splitting up, Does not support and does not associate with people who are flirtatious as female gangsters. Consistent with Peakamen, S. et al(2020), a research study titled "A Guidelines for Applying Buddhist Dharma in Solving Teacher Debt Problems in Khon Kaen Primary Educational Service Area Office, District 5. It was found that the refrain from Causes of ruin included: Refrain from traveling, do not drink intoxicating liquor, do not associate with evil people, do not go out at night, do not play harmful games, do not idle, are



more diligent at work, causing happiness in life as well. The average performance level is 4.51, which is the highest level.

6. The idleness at work as overall, it was at a high level with an average of 3.83. This may be because people are engaged in occupations without encroaching on the lives of their fellow humans and animals, Do not insult honest or low-income careers and also persuade people to make money for people who are unemployed, do not travel, drink alcohol if, have work to be responsible for causing damage to colleagues, have Volunteer to help merit work in the community and temple by free from alcohol and illegal gambling, occupation which is not related to gambling and illegal things. The results of this research, which are inconsistent with Peakmen, S. et al (2020), studied the subject "Approach to applying Buddhist principles in solving teacher debt problems in Khon Kaen Primary Education Service Area Office, District 5. The results of the study found that society used abstinence from Causes of ruin, i.e. abstaining from nightlife, not drinking intoxicating drinks, not being in a relationship with evil people, not having a night out, not playing harmful games, not being lazy, being diligent in More work contributes to happiness in life too, with an average performance level of 4.51, which is the highest.

Recommendation

The drunkenness, a shop operator in a village to refrain from selling liquor during the Buddhist Lent period, wants village leaders to organize training and a program to treat alcoholics.

The moonlighting, parents warn their children not to go out at night because it will cause physical and property harm.

The excursion to play is to enhance family activities, avoid being alone with the husband and wife, not adultery, do not think about cheating on the husband, if the couple is an adulterer is what brings trouble to life.

The gambling wants whether the administrative police come in to deal with the gambling because the leaders can't handle it.

The making friends with evil people would like the police to help deal with the criminals because in the village, the offenders have not yet been punished, and there is still defiance of the law every day for using methamphetamine.

The idleness at work would like to have an income generating event for the unemployed in order to generate income for the unemployed as well.

Further research recommendation

1. There should be a Resolving causes of ruin problems by the 5 Precepts Village Project, Ban Khok Yai, Ban Fang Subdistrict, Ban Fang District, Khon Kaen Province.

2. Research on Resolving causes of ruin problems should be done by the 5 Precepts Village Project, Ban Khok Yai, Ban Fang Sub-district, Ban Fang District, Khon Kaen Province in other village areas in order to compare.
