The characteristics mentioned were very important conditions which have made the herbal specialists survive up to today.

- 2.Recognition of partients was one of principal universal conditions directly resulting in roles and functions of herbal specialists. This was because patients and villagers in general had faith in herbal specialists' characteristics, had confidence in effectivenesses of healing, and held beliefs in healing illnesses with medicinal herbs. And therefore, these caused the herbal specialists to play their roles and perform their functions needed by the community.
- 3. The socio-cultural conditions in the community included the following.
- 3.1 The villagers' traditional beliefs about healing certain illnesses with herbs to which at present the villagers still give importance and practise in healing illnesses by relying on the herbal specialists in the community;
- 3.2 The influences of relationships among family system, relatives, and neighbors in the community cuased relationships relying on aids given to one another as well as participation in expressing ideas, suggesting or choosing how to heal illnesses of the community members. Such influences have resulted in recognizing the treatments by herbal specialists up to present.
 - 4. The effectivenesses of treatments were important

universal conditions. The results of treatments which created satisfaction for the partients and those involved caused faith and recognition of their abilities. In addition, the treatment results made the herbal specialists proud of special abilities of their own which was one of important motivations resulting in the survival of the roles in being herbal specialists.

5. The incomes earned by treating the patients were one of specifically important conditions in the case of herbal specialists as a supplementary occupation. The incomes mentioned could solve family financial problems at a certain level and could be used as rotating funs for continually implementing the activities cocerning medicinal herbs.
